

## Website Privacy Policy

The National Council for Agricultural Education (NCAE) Privacy Policy governs CASE 4 Learning's use of any personally identifiable information ("PII") CASE 4 Learning (CASE) may learn about you ("You" or "Your") when You visit CASE's web site, [www.case4learning.org](http://www.case4learning.org) ("Site"), which CASE may obtain through the Site in connection with Your organization's connection to CASE. In addition to NCAE's Privacy Policy, the Site is governed by a terms of use agreement ("Terms of Use"), which governs in the event of any conflict with this Privacy Policy. This Privacy Policy is effective as of January 1, 2025. National Council for Agricultural Education reserves the right to change this Privacy Policy at any time by notifying You of a new effective date.

**PII Collection, Use and Disclosure.** NCAE may: take Your PII and compile it in a publicly available directory that is accessible on the Site; disclose Your PII to any third party; use Your PII to contact You for NCAE's purposes; combine Your PII with PII that You provide to NCAE in connection with Your use of NCAE's other services and web sites (if any); use third party web site management and advertising contractors to deliver communications to You on NCAE's behalf and to otherwise manage the Site who may be supplied with or have access to Your PII for the purpose of providing these services. Some activities on the Site may be in conjunction with third parties which allow NCAE to offer You certain materials and items. You may be asked to provide Your PII in order to engage in these activities, and that PII may be shared with the third parties. While NCAE's use of Your PII will be subject to this Privacy Policy, the third parties' use of the same PII will fall under their own privacy policies.

**Children.** The Site is not intended for children under the age of 13 years. NCAE does not knowingly collect PII from children under the age of 13.

**Cookies.** NCAE may, now or in the future, place a "cookie" in the browser files of Your computer. In the event NCAE does so, this cookie does not collect PII that personally identifies You as an individual, but merely allows NCAE to recognize Your repeated visits to the Site. If You want to disable cookies, there is a simple procedure in most Internet browsers that allows You to turn off cookies, but please remember that cookies may be required to allow You to use certain features of the Site.

**Links.** The Site contain links to other web sites. In addition, NCAE may, now or in the future, use the Site to "frame" other web sites, in which case other web sites will appear within a NCAE border surrounding such web sites. NCAE does not control these other web sites, even when framed, and You should consult those other web sites' privacy policies regarding their use of Your PII. NCAE may, now or in the future, include advertising in the Site. When You click on an advertisement, the advertiser may be able to collect PII on You and additional PII that You may submit. NCAE does not control these advertisers' collection and use of this PII.
